Summary of outcomes from Aug 27 meeting

- Decision: This responsibility will fall to the Governance Task Group for the time being and Laura will join the Governance Team so we have a county representative.

Mission

Words: Common, Sustainable, Heritage, Respect, Collaborative, Resilient, Getting Outdoors, self-sustaining, responsive, local, connect, cooperation, stewardship, local economy, local benefits, dynamic management, working forests, accessible, invested, diversity, inclusive Others: Recreation, preservation, conservation, wildlife habitat, watershed, cultural, ecosystem services

Inclusive is both an objective and an approach

The 8 words we landed on included: *Connect, collaborative, inclusive, common, accessible, invested, local benefits, sustainable,*

• Vision

Words: adaptive, outreach, leader, cross-boundary, juiced, engaged, representative, guidance, cohesive, community, support, strengthen, oversee, model, support, team,

What the planning committee is: team, cohesive, Engaged/Juiced, adaptive, What the planning committee does: Community, cross-boundary, model, representative, aspiration

• Objectives (weave into the charter)

Create the opportunity on developing a community forest in Kittitas County.

- Using the information and models that we have created
- Reference TNC Bookends:
 - Confidence that development of the property will be restricted, and conservation values will be maintained (e.g., through a conservation easement or transfer to public land management agency)
 - Assurance that public access to the property will be maintained
 - Respect for the treaty rights and cultural practices of tribes
 - Confidence in the management capability, operating expertise, and financial capacity of the future landowner
 - Fair market compensation for the property value
 - Ongoing management objectives that are consistent with the existing federal Habitat Conservation Plan
 - Ongoing management that is consistent with the forest health goals of the Tapash Sustainable Forest Collaborative
 - Active forest management; including forest health restoration and sustainable forest management (consistent with goals of potential funders and communities interests)
 - Development and maintenance of recreational trails as consistent with community and conservation goals
 - Ongoing commitment to pay local property taxes or annual payments *in lieu* of same
- Define community
 - Defined as Kittitas County and the Yakama Nation
 - Outreach emphasis on upper Kittitas County (because of the heavier impact) Fundraising focus is statewide and beyond – terrestrial and aquatic health has major downstream impact
